ORDER

Shri Anurag Kumar, complainant, a person with 50% visual impairment submitted a copy of email dated 16.10.2014 intimating that he was selected in the written examination for Group 'D' held on 01.12.2013. As per the complainant while appearing for the medical examination some official told him that Doctor asked for a sum of one lakh for medical fitness failing which Doctor will unfit you in visual impairment category and give eye power 6/9. As he could not pay the amount, he was declared unfit for visual Impairment category. He again appealed for re-medical examination, which was re-scheduled in the same hospital and before the same board. Again an official demanded 1.5 lakhs for declaring him visually impairment. He requested to direct the Railway Recruitment Cell to arrange his re-medical examination in other Hospital.

2. This Court took up the matter with the Chairman, Railway Recruitment Cell, Eastern Railway, Kolkata vide letter dated 11.08.2015 to submit their comments in the matter. Eastern Railway, Kolkata vide letter dated 26.08.2015 intimated that on examination, it is seen that Shri Anurag Kumar appeared in the written examination conducted by RRC, Central Railway, Haijuri and not RRC, Eastern Railway, Kolkata. Hence, they returned this Court's letter for further necessary action. The matter was again taken up with the Chairman, RRC, Eastern Central Railway, Patna vide letter dated 28.09.2015 for submission of their comments in the matter.



Eastern Central Railway, Patna vide letter dated 16.03.2016 intimated this Court that vide their letter dated 19.10.2015 they have already intimated this Court that as pointed out by Shri Anurag Kumar the matter of Shri Ranjit Kumar Choudary son of Shri Ram Avtar Choudhary, Control No. 22806402, Written Examination No. 1070990110 was examined and he was found unfit as VH. However, they did not offer any comments on the complaint of Shri Anurag Kumar. A hearing in the matter was fixed for 28.04.2017.
4. During the hearing on 28.04.2017 the complainant was absent nor any intimation was received about his inability to attend the hearing, despite the fact that the Notice of Hearing was sent on 24.03.2017 by Speed Post. The representative of the respondent was present at the time of hearing.
5. The Court took a serious view of absence of the complainant to present his view point. In the light of Rule 42(4) of the Persons with Disabilities Rules, 1996, the Court dismissed the complaint in default.
6. The case was accordingly disposed off.
